Return the completed form to the address shown above, along with your check for \$50.00 (made out to Oldenburg Horse Breeders' Society) if you are already an active member for 2012. The transfer of ownership fee for a non-member is \$115, and this will not only pay for the transfer of ownership, it includes a full membership for 2012 when you complete the membership form and this form. Full membership will allow you to partake in the Year-End Awards program, receive the quarterly magazine, "The Oldenburg Horse and Weser-Ems Pony", and will allow you to take foals, mares, and stallions to inspections for registration and/or breeding approvals. We are also happy to promote your Oldenburg horse on our website and in the magazine.

Once you have completed the necessary form(s) and have made out your check, be sure to also include the original white ownership papers **AND** the original passport if born in 2000 or later. If the horse was born before the year 2000, the horse may only have original pink papers. The green passport from the FN if he/she was born in Germany is not the correct passport. We require the papers and passport issued by the breed organization.
